HRE 2020 at Human Rights Council

HRE 2020 Global Coalition Member Soka Gakkai International (SGI) participated in the two informal consultations on the Resolution for Human Rights Education as part of 31st regular session of the Human Rights Council (29 February-24 March 2016).

In the Second Informal Consultation on March 9th, Hayley Ramsley-Jones spoke on behalf of HRE 2020 to support including civil society organizations in the resolution. "We welcome the inclusion of civil society within the text and we echo the comments made by my colleague earlier concerning the importance of engaging civil society at all levels, including monitoring and evaluation." Ramsey-Jones also presented HRE 2020's *Human Rights Education Indicator Framework* as a tool for monitoring and assessing the implementation of HRE and welcomed further collaboration.



Human Rights Education Indicator Framework Now Available in French and Spanish

HRE 2020's first publication, *Human Rights Education Indicator Framework: Key indicators to monitor and assess the implementation of human rights education and training*, is now available in French and Spanish. Following positive reception of the English-language guide for the review of human rights education, the coalition has translated the document into two additional languages. 
Henri Tiphagne wins Amnesty award

In recent years, many organizations have come under intense pressure from the Indian government, and People's Watch is no exception. As stated by Selmin Çalýþkan, Director of Amnesty International Germany, "Henri Tiphagne and his organization People's Watch, are fighting to ensure the rights of others and yet they themselves are being harassed and hampered by the authorities. There are many other civil society organizations in India that are in a similar position. People's Watch has been researching and documenting human rights violations and providing legal representation to those affected for over 20 years. It also undertakes programs on human rights education through its sub-unit the Institute of Human Rights Education (IHRE), which has been recently established as an independent entity. The IHRE has plans to focus on advocating for the right to education and human rights education and building a bridge between the two over the next five years. Member profile: Women for Women's Human Rights-New Ways (WWHR)



Women for Women's Human Rights-New Ways

(WWHR) is a women's NGO that aims to promote women's human rights, equality, and non-discrimination in Turkey and on the international level.

Through two decades of activism, advocacy and networking, WWHR-New Ways has contributed significantly to numerous legal reforms; increased rights awareness of women and the realization of women's human rights in Turkey; the advancement of sexual and bodily rights in Muslim societies, and promotion of women's human rights at the UN-level.

One of the primary programs of WWHR-New Ways is their Human Rights Education Programme for Women (HREP), a holistic and comprehensive 16-module program that is implemented on a weekly basis over a four-month period through participatory group meetings. Since 1995, HREP has reached over 12,500 women through uninterrupted implementation. The program aims to raise participants' awareness on gender discrimination and women's human rights violations, and emphasize the importance of independent women's organizing and the women's movement in the struggle against discrimination and rights violations.
